



Public Hearing on Amended Road District Budget and Appropriation Ordinance #2017-02-A

Meeting called to Order at 7:00PM by Supervisor Smith

Clerk Prater called roll call: Trustee Guglielmi, Trustee Alekna, Trustee Voelz, Trustee Halley and Supervisor Smith were all present.

Trustee Guglielmi asked if the budget had been posted. Trustee Alekna asked if it was posted to the Website. Supervisor Smith stated she thought it was posted to the website. Supervisor Smith advised the budget was posted there for thirty days and gave notice to the public for the hearing. According to Lawyer Rick Tarulis, the township complied with all necessary publications and postings. Highway Commissioner John Dusza advised the reason for the amended budget was because of an accident with a vehicle owned by the township as we need it to accept the check for \$12,000 for the damaged truck. Trustee Guglielmi would like in the future to utilize the website and put information like the Amended Road District Budget and appropriation Ordinance #2017-02-A on the web for the public to review.

Trustee Guglielmi made a motion to accept the Amended Road District Budget and appropriation Ordinance #2017-02-A Second by Trustee Halley. Motion carried on roll call vote.
