7:42PM - Closed Session for Semi-Annual review of Executive Session Minutes 5 ILC S 120 2 C 21-Discussion of Minutes of the meetings lawfully closed under this Act, whether for purpose of approval by the body of the minutes or semi-annual review of the minutes as mandated by section 2.06.
