Ordinance 2019-01 Proposed Town Budget. Supervisor Smith advised this is the final copy in front of you. We trimmed \$98,000 from last year out of the budget. Thank you for your contribution. Our Hearing will be held prior to the May meeting and voted on during the meeting. Trustee Guglielmi, now that we have the actuals, we can play with the numbers and get it balanced. Supervisor Smith advised it really is balanced; it is not considered balanced until the end of the year. The money needs to be there in order for us to spend it.

Ordinance 2019-02 Proposed Road Budget. Highway Commissioner John Dusza advised he gave the last five years' of comparison for the Board. The equipment is up a little. We need a new dump truck and



work on replacing the bucket truck. All other lines are in line from last year. We are buying salt with MNT monies. If you have any comments or questions, please call me.

Highway Commissioner's Report. Inventory of all equipment. Supervisor Smith asked if Highway Commissioner John Dusza would like a motion to have the Board accept the report showing the Board received it. Highway Commissioner John Dusza stated that was not necessary.

Trustee Guglielmi – Nothing.




Motion for Adjournment was made by Trustee Halley. Second by Trustee Voelz. No further discussion. Motion carried on voice vote.


