Ride DuPage – Two rides report of 2019 was given to the Board for Winfield Township bus and what we have from Ride DuPage. Trustee Halley asked if Supervisor Smith had heard back about the complaint that had been made last month. Supervisor Smith advised she had not. She advised that two and half hours to wait on a bus Pace stated it is adequate wait time. Trustee Alekna stated 2½ hours is extremely excessive; I do not think that individual should be using this particular service.
