ORDINANCE NO. 2021-06

An ordinance levying taxes for all road purposes for Winfield Township Road District, DuPage County, Illinois, for the tax year 2021, collectable in 2022.

BE IT ORDAINED by the Board of Trustees of Winfield Township, DuPage County, Illinois as follows: SECTION 1: That the Highway Commissioner of Winfield Township Road District on December 13, 2021

does hereby determine and declare that the sum of Two Million, One Hundred Eighty Four Thousand and 00/100 Dollars (\$2,184,000.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:
