1. Shall Winfield Township have a single waste hauling company for all residents of unincorporated areas of Winfield Township?

It has come to the board's attention that we could benefit the township by having its own sheriff's deputy. For this to happen a levy must be created to acquire a deputy. The cost for one deputy is \$120,000.00. this levy would only be for unincorporated Parcels to pay. There is an estimate of 3100 parcels. That would mean \$120,000.00 divided by 3100 an estimate of \$38.71 Tax to the unincorporated parcels for a deputy to be in the township.

2. Shall Winfield Township hire its own deputy to patrol the unincorporated areas of Winfield Township?
