IV. Programs Offered by our Township.

A. The Road District maintains 40 miles (80 lane miles) of road rights-of-way which are many of the streets in the unincorporated areas of Winfield Township. The road-right-of way consists of paved streets, shoulder gravel and an additional area that is used for

drainage. Within the right-of-way the Road District assumes many responsibilities, with maintenance among the highest of those responsibilities. On any given day, the Road District may be required to address among other things, asphalt patching, asphalt resurfacing, gravel shouldering, drainage, litter removal, leaf removal, road striping, traffic control signage, winter tree removal, winter snow and ice control and J.U.L.I.E locates.

The Road District has an annual leaf removal program, scheduled brush pickups throughout the spring and fall; and storm debris pick-up as deemed necessary along with Christmas Tree recycling drop off and used cooking oil recycling drop off. The Road District holds an annual recycling event that is offered to its residents and anyone in the surrounding area.

The Road District prides itself in serving our taxpayers (and the general, traveling public as a whole) in both its road-related work and its additional programs.

Our committee will continue to consider the possibility of offering additional potential partnerships.

V. <u>Awards and Recognitions</u>

Our Township Road District has received the following awards, distinctions, and recognitions:

The Road District received the Earth Flag through DuPage County and Scarce.

Scarce guides schools, municipalities, and organizations to reach their environmental goals. They can assist with recycling, composting, energy conservation, and green cleaning projects.

The Earth Flag is a program offered jointly by Scarce and DuPage County. Each group has an evaluation ("green audit") of their facilities, staff trainings, and must complete an eco-volunteer activity.

The Winfield Township Road District sends out approximately 16,798 Homeowners Handbooks to its residents every other year and updates it yearly on our website. The Handbook discusses everything the Road District offers throughout the Township as well as listing important dates. The Road District holds an Annual Recycling Event in the fall. We apply for a grant every year from DuPage County's Environmental Division to utilize their Document Shredding Program that they offer to municipalities to help with funding for paper shredding services offered to residents during the event. We also have a Leaf Removal Program for all Unincorporated Residents in the fall along with Brush Pickup 4 times a year, twice in the spring and twice in the fall. The Road District also provides extra storm brush pick-ups if/when needed.

Each year we consider any appropriate reductions in our tax levies and have worked to freeze and/or cap certain funds whenever it is prudent to do so.

The Road District receives requests under Illinois' Freedom of Information Act, and prides itself in responding within the statutory deadline or agreed upon date with the requestor.

The Road District works hard throughout the year to make sure the residents' needs are met. Our office appreciates all feedback received from residents.

I. What Inefficiencies Did We Identify/What Are our Next Steps? In prior administrations, the standard was set for handwritten notes related to specific jobs/tasks in our Road District. This creates the potential for things to be misplaced

or left undone. Recently, we have created a Work Ticket and Sign Program online. Jobs/tasks are now put into the Work Ticket Program and given a number. When the job is completed, we go in and mark it closed. This way we can log in and see any open, outstanding, and completed jobs. The Sign Program works similarly. It can show us what signs we have up in the township and where they are located. It helps us stay more efficient. We will continue to monitor this process and take any further steps as required to make it more efficient.

II. What Can We Do Better or More Efficiently?

We continue with our comprehensive review of our rights-of-way that are not formal roadways. The goal is to reduce any motor fuel tax monies received if they are not utilized by the traveling public. Accordingly, we have, and will continue to use the statutory road vacation process to remove those areas from our highway system, where appropriate.
