TAX LEVY ORDINANCE





ORDINANCE NO. 2024-04

An ordinance levying taxes for all road purposes for Winfield Township Road District, DuPage County, Illinois, for the tax year 2024, collectable in 2025.

BE IT ORDAINED by the Board of Trustees of Winfield Township, DuPage County, Illinois as follows: SECTION 1: That the Highway Commissioner of Winfield Township Road District on October 14, 2024 does hereby determine and declare that the sum of Two Million, Five Hundred Nine Thousand and 00/100 Dollars (\$2,509,000.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of the ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adaption, as provided by law.
