

RESOLUTION 2024-1  
RESOLUTION FOR DEPOSITORIES FOR FUNDS  
FOR WINFIELD TOWNSHIP

Be it Resolved by the Board of Trustees of Winfield Township, DuPage County, Illinois, that the following Federally Insured Depository Institutions are hereby designated as the depositories of the funds of Winfield Township, and that the Elected Officials of said Winfield Township are hereby authorized to endorse, in the name of Winfield Township for the purpose of deposit and collection in and with said Federally Insured Depository Institutions, checks, drafts, notes and other like obligations, issued or drawn to and owned by Winfield Township, and it is further resolved that endorsements for deposit and collection may be by the written or stamped endorsement of Winfield Township without designation of the party making the endorsement.

Said Federally Insured Depository Institutions are hereby authorized to pay out the funds of Winfield Township on deposit with said Institutions from time to time upon checks drawn upon said Institutions and signed in the name of Winfield Township by its Supervisor or Trustees so authorized and countersigned by its Town Clerk or Trustees so authorized whether said checks are payable to bearer or the order of Winfield Township, or to any third party, or to the order of any signing or countersigning official of Winfield Township or and other official of Winfield Township, in either their individual or official capacity.

The Town Clerk of Winfield Township shall file with the said Institutions a certified copy of this Resolution under the seal of Winfield Township and shall also file with the said Institution a certified list of the persons at the present time holding the elected offices of Township Supervisor, Township Clerk, and Township Board of Trustees of Winfield Township, and it shall be conclusively presumed that the persons so certified as holding such offices continue respectively to hold the same until the said institution is otherwise notified in writing by the Town Clerk of Winfield Township.


This Resolution shall be in full force and effect and binding upon Winfield Township until it shall have been rescinded, and written notice of such rescission under the Township Seal shall have been delivered to said Institution.

**RESOLUTION 2024-3  
WINFIELD TOWNSHIP**

**Elected Officials Salary and Compensation Rate for Four-year Term  
Beginning May 2025 and the Assessor's Term Beginning January 2026**

WHEREAS, the Board of Trustees of Winfield Township is required by law, not later than 180 days prior to the next term of office, to fix the compensation for the Township Elected Officials whose term begins May 2025 and end May 2029, and the assessor's term beginning January 1, 2026 and ending December 31, 2029 and;

WHEREAS, this said board has diligently and carefully reviewed the functions and responsibilities of the elected official's offices to be filled at the consolidated election to be held in April 2025;

NOW, THEREFORE BE IT RESOLVED by the Board of Trustees of Winfield Township that the compensation for the Winfield Township Elected Officials for the four-year terms, beginning May 2025, and the Assessor's term beginning January 1, 2025, shall be annual as follows:

BE IT FURTHER RESOLVED that the Supervisor, shall be paid, as provided for by statute, an additional \$1,000 annually as Treasurer of the Winfield Township Road District Funds.

BE IT FURTHER RESOLVED that the Supervisor, Assessor and Highway Commissioner are eligible for Township Medical, Dental, and Life Insurance, and may Participate in such plans, under the same term as the Township Employees.


BE IT FURTHER RESOLVED that the Supervisor, Assessor and Highway Commissioner may participate in the Illinois Municipal Retirement Fund (IMRF);

BE IT FURTHER RESOLVED for the Highway Commissioner's salary \$100,000 comes out of Town Fund and any amount over that comes out of Road fund.

BE IT FURTHER RESOLVED that the Supervisor, Clerk, Highway Commissioner and four Trustees begin their new term of Office in May 2025, and this compensation Resolution for these offices is effective as the new term of office beginning in May 2025;


BE IT FURTHER RESOLVED that the Assessor begins his new term of office on January 1, 2026 and this Compensation Resolution for the office of assessor is effective as the new term of office beginning January 1, 2026

**RESOLUTION 2024-4  
WINFIELD TOWNSHIP**

**RESOLUTION TO SUBMIT AN ADVISORY REFERENDUM TO THE VOTERS OF WINFIELD  
TOWNSHIP REGARDING CONSTITUTIONAL PENSION REFORM**

**WHEREAS**, Winfield Township, Illinois is a duly organized and existing township created and operating under the provisions of the Illinois Township Code and the laws of the State of Illinois; and,

**WHEREAS**, the Illinois Election Code provides that any public question authorized by statute shall be initiated in accordance with 10 ILCS 5/28-1 and 5/28-5; and,

**WHEREAS**, Section 80-80 of the Township Code, 60 ILCS 1/80-80, provides that, by a vote of a majority of the township board, the township board may authorize that an advisory question of public policy be placed on the ballot at the next regularly scheduled election in the township; and,

**WHEREAS**, as of Fiscal Year 2023, Illinois public pension systems' collective funding ratio of 50.8% was the lowest in the nation; and,

**WHEREAS**, public pension spending makes up nearly \$10.5 billion, or 20% of the state's Fiscal Year 2025 General Funds Budget; and,

**WHEREAS**, Illinois taxpayers owe \$211 billion in unfunded state and local pension liabilities; and,

**WHEREAS**, residential property taxes in Illinois have increased 215%, or \$15.8 billion since 1996, in part to pay for increasing local pension costs; and,

**WHEREAS**, the Township Board of Winfield Township, Illinois find it to be in the best interests of Winfield Township, Illinois to put a non-binding, advisory referendum question on the ballot regarding whether the state of Illinois should enact constitutional pension reform to protect workers' existing retirements and generate savings which could provide property tax relief or be reinvested in the community, and that said question should be submitted by referendum to the Winfield Township electorate at the April 1, 2025 consolidated election.

**NOW THEREFORE, BE IT RESOLVED** by the Board of Winfield Township that the County Clerk is hereby authorized and directed to place on the April 1, 2025, Consolidated Election Ballot in Winfield Township the following non-binding, advisory, public question in accordance with applicable law:

Should the state of Illinois enact constitutional pension reform to protect workers' existing retirements and generate savings which could provide property tax relief or be reinvested in the community?
