**TAX LEVY ORDINANCE**  
**TOWNSHIP**

ORDINANCE NO. 2025-08

AN ORDINANCE LEVYING TAXES FOR ALL TOWN PURPOSES FOR WINFIELD TOWNSHIP, DUPAGE COUNTY, ILLINOIS, FOR THE TAX YEAR 2025 COLLECTABLE IN 2026.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF WINFIELD TOWNSHIP, DUPAGE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: That the sum of **Two Million Four Hundred Twenty-Six Thousand Eight Hundred Thirty-Two Dollars (\$2,426,832)** are hereby levied upon all property subject to taxation within the township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Corporate Tax (Town Fund)

Public Assistance Tax (General Assistance Fund)

for the year 2025.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

**TRUTH IN TAXATION  
CERTIFICATE OF COMPLIANCE  
(35 ICS 200/18-90)**

I, the undersigned, hereby certify that I am the presiding officer of Winfield Township. And as the presiding officer, I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth In Taxation" law.

INCREASE FOR WINFIELD TOWNSHIP**

- I. A public hearing to approve the proposed property tax levy increase for Winfield Township for the year 2025 will be held on Monday, December 8, 2025 at 6:45 P. M. at 130 Arbor Avenue, West Chicago, IL 60185. - II. The corporate and special purpose property taxes extended or abated for 2024 were \$1,307,940.45. The proposed corporate and special purpose property taxes to be levied in 2025 are \$2,426,832.00. This represents an 85.5% increase over the previous year.
- III. The property taxes extended for debt service and public building commission leases for 2024 were \$0.00. The estimated property taxes to be extended for debt service and public building commission leases for 2025 are \$0.00. This represents a zero percent (0%) increase over the previous years.
- IV. The total property taxes extended or abated for 2024 were \$1,307,940.45. The estimated total property taxes to be levied for 2025 are \$2,426,832.00. This represents an 85.5 % increase over the previous year.


